## **BACKGROUND**

ARC is an international non-profit organization that has provided humanitarian assistance to millions of beneficiaries over the past 30 years. ARC works with refugee, IDP and affected communities in ten countries around the world, helping people regain control of their lives after conflict and natural disaster. ARC has been responding to the humanitarian/refugee crisis in Thailand since 1992 addressing issues relating to GBV, Health, and WASH sectors, with funding from BPRM, USAID, UNHCR, and many others.

ARC has been working in Southeast Asia since 1978 and in Myanmar since January 2014, where it has been implementing its project, *Extending effective malaria control and artemisinin resistance containment activities to hard-to-reach and transient populations in priority areas of Southeast Myanmar*. ARC is a subrecipient working as part of the Global Fund (GFATM)-supported Regional Artemisinin Initiative (RAI) from 2014 to date while in Thailand since 2007. ARC is also a recipient of RAI2E regional package to host the malaria CSO platform in the GMS.

ARC as a host of regional CSO platform together with 5 Country CSO partners are organizing Malaria CSO platform for National and Regional Malaria CSO consultations. The purpose of the national consultations is to bring Non-Governmental Organizations (NGO), community-based network, malaria risk population network and country CCM malaria representatives in one place and to discuss the effectiveness of Regional Artemisinin Initiatives 2 Elimination (RAI2E) implementation. The purpose of the regional CSO consultation is to provide unique opportunity to learn and to share information among the CSOs of RAI2E implementing countries.



The consultant is expected to have broader consultation with RAI CSO representatives, CSO platform Secretariat team and other key stakeholders of the malaria CSO platform to finalize the consultation meeting report.

#### **PURPOSE**

Main purpose of this contract is to document Malaria CSO platform's Regional consultation on way forward of CSO engagement on the update on RAI3E funding request on 5-6 March in Bangkok, Thailand. The note taker is responsible for providing accurate and complete information from the consultation and workshop details.
